Who am I speaking with Shylee or Rochelle because at the bottom of the email it says Rochelle?. But Our Master Lease Agreement that i signed states on page 5 paragraph 12 that NO EMPLOYER-EMPLOYEE relationship exists hence and it is a **independent contractor agreement (1099)** and not a employment agreement (W2) in which im responsible for my own workmen's compensation , insurance etc .

The fact that it is a independent contractor (1099) contract it governed under the laws of the State of North Carolina and makes it a civil matter which has to be handle by a lawyer and not the DOL (department of labor) . Trust me the DOL would of been contacted you if it was in their jurisdiction. The North Carolina DOL are the one's who referred me to the lawyer firm and told me why I had to obtain a lawyer for the same fact you pointed out its a independent contractor dispute .






I have attached our Master Lease Agreement because no where in the agreement states you have the right to withhold final settlement until ALL shipments your truck transported, while leased to CRWT2 Inc, has passed the claim period - Typically anywhere from 90-180 days but clients (brokers and shippers have 365 days to legally file a claim). But it does says Total payment shall be made within 15 days after submission of the necessary delivery documents and other paper work concerning a trip in the service of LESSEE.

If this is Shylee the last time we spoke you said Carlton knows he owes you (Lemar) and he is driving his ass off in his own truck to pay you back but our other trucks went down and the factoring company is stalling on paying us etc. Then you stop answering my calls (like to day) and replying back.
